Applicant accepts the following conditions and acknowledges that the permission is subject to them:

CONDITIONS

1. The applicant must comply with all rules regulations established by the Administrative Board of the Port of Ponce, the Commonwealth of PR and the Federal Maritime Commission.
2. The applicant agrees to submit one copy each of the inbound and outbound manifest, duly signed by the Master of the vessel, NOT LATER THAN TWO (2) WORKING DAYS after the termination of operations. In addition, applicant shall submit any and all documents which the Port of Ponce may deem necessary.
3. The Administrative Board of the Port of Ponce may order the relocation of the vessel to another pier, to another berth, or to the anchorage area when considered necessary. Cost of relocation be borne by the vessel, owners or agents..
4. The applicant shall be responsible to the Administrative Board of the Port of Ponce for the payment of wharfage, dockage, damage to the property of the Port and/or any third party and all other applicable charges related to the vessel..
5. The applicant authorizes the Administrative Board of the Port of Ponce to send him all invoices for the applicable charges (wharfage, dockage, etc.) related to the service, use of facilities and/or fines and penalties accrued..
6. This form shall be filed at the Administration office NOT LATER THAN 24 HOURS PRIOR TO THE ARRIVAL OF THE VESSEL. If the vessel does not arrive 24 hours after the estimated time of arrival, this permit is them automatically cancelled. The agent must then submit a new DOCKING APPLICATION & PERMIT.
7. The applicant agrees to assume and be responsible, before the Administrative Board of the Port of Ponce and/or any third party, for every and all expenses, damage and/or liability caused to any vessel with a docking permit granted by the Port Administration with effective berth approaching time for any time after the departure hour stated in the applicant's applications, therefore, the applicant releases and will hold harmless the Administrative Board of the Port of Ponce from any and civil liability arising from the delay in removing the vessel from the assigned berth after the stipulated departure time.
8. This application will be rejected in the event the applicant has debts with the Port of Ponce. The applicant could pay off debt balance before receiving the corresponding Docking Permit.
9. Violations to the above conditions will be sanctioned according to the law, including deviations to the requirements for operating as shipping agents.
